**Rainer Bauböck** is professor of Social and Political Theory at the Department of Political and Social Sciences of the European University Institute. His research interests are in normative political theory and comparative research on democratic citizenship, European integration, migration, nationalism and minority rights. Together with Jo Shaw (University of Edinburgh) and Maarten Vink (University of Maastricht), he coordinates Globalcit, an online observatory on citizenship and voting rights
