

Alessandro Ferrara is Professor of Political Philosophy at the University of Rome Tor Vergata and former President of the Italian Association for Political Philosophy. Recently he has published *Rousseau and Critical Theory* (Brill, 2017) and *The Democratic Horizon. Hyperpluralism and the Renewal of Political Liberalism* (Cambridge UP, 2014). He has also authored *The Force of the Example. Explorations in the Paradigm of Judgment* (Columbia UP, 2008); *Justice and Judgment* (Sage, 1999), and *Reflective Authenticity* (Routledge, 1998). An editorial advisor to *Constellations, Philosophy and Social Criticism* and *The European Journal of Philosophy*, co-editor of the series *Philosophy & Politics* (Springer), he serves as co-director of the yearly Conference *Philosophy and Social Science*, yearly held in Prague under the aegis of the Czech Academy of Science.

Valentina Gentile is Vice-Director of the CEGP (Center for Ethics and Global Politics) at Luiss University in Rome and a Lecturer in Global Justice and Corporate Social Responsibility at the same University. She is also a Guest-Professor at Antwerp University (Belgium) where she holds a Cusanus-chair in 'Interreligious Dialogue and the Ethics of Peace'. She specializes in normative political philosophy, liberal theory and, especially, the work of John Rawls. Her research focuses on moral stability, pluralism and the principles of reciprocity, toleration, equality and social justice. Her recent publications include: "From a culture of civility to deliberative reconciliation in deeply divided societies" (*Journal of Social Philosophy*, vol. 49, n. 2, 2018, pp. 229-251); "Clean trade, anti-paternalism and resources' entitlement" (*Philosophy and Public Issues - New Series*, vol. 7, n. 1, 2017, pp. 79-94); "Democratic justice: The priority of politics and the ideal of citizenship" (*Critical Review of International Social and Political Philosophy*, n. 20, 2017,

pp. 211-221). She has been co-editor of the collection, *Rawls and Religion* (Columbia University Press, 2015), and author of *From Identity-Conflicts to Civil Society: Restoring Human Dignity and Pluralism in Deeply Divided Societies* (Luiss University Press, 2013).

John Horton is Professor Emeritus of Political Philosophy at Keele University (UK). He is the author of *Political Obligation* (rev ed., 2010); editor or co-editor of several volumes on toleration, and on Alasdair MacIntyre, John Gray, *modus vivendi* and political theory and literature; and author of numerous articles on contemporary political philosophy.

Davide Pala is a PhD Student and Teaching Assistant at the Department of Politics of the University of Manchester. He works within the Manchester Center for Political Theory (MANCEPT) in the field of normative political theory applied to international and transnational questions. In particular, he is currently developing a neo-republican conception of human rights, understood as a standard for assessing the justice of the “global order”. His publications include articles on moral institutional cosmopolitanism, capability approach, and liberal nationalism, respectively.

Roberta Sala Full professore of Political Philosophy, Faculty of Philosophy, Vita-Salute San Raffaele University in Milan. She teaches also Bioethics to Nursing and Medicine students at the same university. Research subjects: toleration, liberalism, multiculturalism, public bioethics.

Federico Zuolo is currently Assistant Professor at the University of Genova. Before joining the University of Genova he held positions in Pavia, Trento, Hamburg and Berlin. His interests include public justification, animal ethics, toleration, respect, the treatment of diversity, and some issues in the history of philosophy. He published a monograph on Plato (Academia 2009), a new edition of Xenophon’s *Hiero* (Carocci 2012) and an introduction to animal ethics (*Etica e animali. Come è giusto trattarli e perché*, il Mulino, 2018).
