

Francesca Cesarano is a PhD student in political philosophy at San Raffaele University (Milan) and a visiting doctoral fellow at Vrije Universiteit (Amsterdam). Her research project focuses on the alleged conflict between multiculturalism and feminist claims. Before starting a PhD programme in Milan, she obtained a master's degree in political theory at the University of Sheffield and a bachelor's degree in philosophy at the University of Pavia.

Alessandro Ferrara is Professor of Political Philosophy at the University of Rome Tor Vergata and teaches Legal Theory at Luiss Guido Carli University in Rome. He has served as President of the Italian Society for Political Philosophy (2005-2010) and is Co-Director of the Prague Conference on Philosophy and Social Science. Among his recent volumes are: with Frank Michelman, *Legitimation by Constitution. A Dialogue on Political Liberalism* (OUP, 2021); *Rousseau and Critical Theory* (Brill, 2017) and *The Democratic Horizon. Hyperpluralism and the Renewal of Political Liberalism* (CUP, 2014). Earlier he published *The Force of the Example. Explorations in the Paradigm of Judgment* (Columbia UP, 2008); *Justice and Judgment* (Sage, 1999), and *Reflective Authenticity; Rethinking the Project of Modernity* (Routledge, 1998).

Ferrara has a new volume forthcoming in 2023 with OUP, titled *Sovereignty Across Generations. Constituent Power and Political Liberalism*, on the opposition of sequential and serial conceptions of democratic popular sovereignty.

Anna Elisabetta Galeotti is Full Professor of Political Philosophy at the University of Eastern Piedmont, Vercelli. Her research interests range from toleration, multiculturalism, equal respect to deception, self-deception and distorted communication in politics. Among her English publications: *Toleration as Recognition* (Cambridge University Press, 2002), “Autonomy and Cultural Practices: The Risk of Double Standards”, *European Journal of Political Theory* (2015), “The Range of Toleration”, *Philosophy and Social Criticism* (2015), “Cultural Conflicts: A Deflationary Approach”, *Critical Review of International Social and Political Philosophy* (2017), *Political Self-Deception* (Cambridge University Press, 2018), “Rescuing Toleration”, *Critical Review of International Social and Political Philosophy* (2019, with F. Liveriero), “Toleration between Liberty and Security”, *Journal of Ethics* (2021, with C. Meini), “Scientific Disinformation and Fake News: A Blurred Boundary”, *Social Epistemology* (2022).

Valentina Gentile is an Assistant Professor in Political Philosophy at LUISS University of Rome. She held positions at Antwerp University (Belgium), University College of London (UK) and the University of Utrecht (Netherlands). She specializes in normative political theory, liberal theory and the work of John Rawls, in particular. Her research focuses on the relationship between religion and politics, the normative ideal of stability, pluralism and the principles of reciprocity, tolerance, equality and social justice. Her research appeared in *Journal of Social Philosophy*, *International Theory*, *CRISPP - Critical Review of Social and Political Philosophy*, *Global Policy*, *Philosophia*, *PPI-Philosophy and Public Issues*, *BdL-Biblioteca della Libertà*. She is author of *From Identity-Conflicts to Civil Society: Restoring Human Dignity and Pluralism in Deeply Divided Societies* (LUISS University Press, 2013), and co-edited the volumes, *Rawls and Religion* (Columbia University Press, 2015) and *Space of Tolerance* (Routledge, 2020).

Sebastiano Maffettone is a political philosopher and a public intellectual. He teaches at LUISS University of Rome, where he also leads the “Osservatorio Ethos”. He was the first President of the Italian Society of Political Philosophy and held visiting professorships in several Universities all over the world. He is the editor-in-Chief for the academic journal *Philosophy & Public Issues* (formerly *Filosofia e Questioni Pubbliche*) and serves on the editorial board of several prestigious international journals. He was among the first Italian scholars who contributed to the spread of Rawls’ scholarship in Italy.

David A. Reidy is Professor of Philosophy and Adjunct Professor of Political Science at the University of Tennessee. On Rawls, he has published widely and has edited or co-edited several volumes, including *The Blackwell Companion to Rawls* (2104), *The Cambridge Rawls Lexicon* (2015), and *Rawls's Law of Peoples: A Realistic Utopia?* (2006). He is currently completing a monograph situating within intellectual and political history Rawls and his work.
