

Kenneth Baynes is Professor of Philosophy at Syracuse University in New York and the author, most recently, of *Habermas* (Routledge, 2016).

Richard Bellamy is Professor of Political Science at University College London (UCL), University of London. His publications include *Liberalism and Pluralism: Towards a Politics of Compromise* (Routledge, 1999), *Political Constitutionalism: A Republican Defence of the Constitutionality of Democracy* (Cambridge University Press, 2007) and, most recently, *A Republic of European States: Cosmopolitanism, Intergovernmentalism and Democracy in the EU*, (Cambridge University Press, 2019) and (with Dario Castiglione) *From Maastricht to Brexit: Democracy, Constitutionalism and Citizenship in the EU*, (ECPR Press/Rowman and Littlefield, 2019). He is currently co-editing *The Cambridge Handbook of Constitutional Theory* and working on a book on democratic ethics.

Giulia Bistagnino is Postdoctoral Research Fellow in Political Theory and Adjunct Professor of Political Philosophy for the Ph.D. programme in *Political Studies* at the Department of Social and Political Science of the University of Milan. She holds a Ph.D. in Political Studies from the University of Milan and a M.Litt. in Philosophy from the University of St. Andrews. She was junior visiting scholar at Nuffield College, Oxford and at the Hebrew University of Jerusalem. Among her most recent works, there are: “Disagreement, Peerhood, Compromise” appeared in *Social Theory and Practice* (2018), written with Federico Zuolo, and “Liberalism, pluralism, and a third way”, forthcoming in *What is pluralism?* (Routledge, 2020).

Detlef von Daniels is a Visiting Fellow at the Centre of International Studies (CIS) at the London School of Economics. He is interested in the intersections between legal theory, international relations, and philosophy, both in current theorizing and in the history of ideas.
