

**Marco Biasi** is Lecturer of “Labor Law” at the University of Milan. He is Teaching Fellow of “Comparative Industrial Relations Law” at Bocconi University in Milan, where he completed his Ph.D. in 2013. He was Visiting Professor at Cornell University from July 2015 through September 2015, Post-Doc Research Fellow at Ca’ Foscari University in Venice from 2014 through 2015. He was visiting Ph.D. candidate at the Friedrich Schiller Universität in Jena (from March 2012 through August 2012). Biasi was the recipient of the Lincean Academy’s 2014 Francesco Santoro-Passarelli Prize for the “Best debut book by a Labour Law Scholar in 2012-2013” due to his first monographic work on employee involvement from a comparative perspective, based on the German, European, and Italian experiences. Additionally, he edited with Professor Zilio Grandi of Ca’ Foscari University an extensive commentary on the “Jobs Act” Reform of the Italian labor market and a commentary on labor in firm networks, both published by Cedam (respectively, in 2016 and 2015). He is currently finalizing a monographic work on wrongful dismissal in Italy.

**Carlo Burelli** received his PhD in 2015 from Università Statale di Milano under the supervision of Antonella Besussi, defending the thesis: *The Normative Power of Necessity: Making Sense of Political Realism*. In 2014 he was visiting PhD at the University of Cambridge under Raymond Geuss. Since 2015 he has been working as Post-Doc Research Fellow in the ERC Project RESceU, directed by Maurizio Ferrera, where he investigates political conflicts and realistic forms of solidarity. He has written articles on Political Realism and the

philosophy of Thomas Hobbes. He is also the author of a short monograph on game theoretic interpretations of Hobbes's "state of nature" (*E fu lo Stato*, 2010).

**Giulio Ferraresi** obtained a Master's degree in Legal and Political Theory from University College London in 2012.
